5b) Sustainable Rural Communities: Review of Rural Issues in Wiltshire: SDC/s press release for the document says: 'This report has been produced by the district council's Sustainable Rural Communities Scrutiny Review Group chaired by Cllr. Catherine Spencer. It makes several recommendations to the new Wiltshire Council when it is formed next year. The report containes more than 25 recommendations, the most fundamental being that the new Wiltshire Council makes rural regeneration a top priority for the county. Another key recommendation is that the £1 million that is expected to be raised across Wiltshire from council tax collected on second homes should be ring-fenced and spent on improving rural services. This is based on findings that, of the 500 second homes in rural south Wiltshire, most are owned by weekenders who contribute little to the rural economy or community life in the villages. The review looked at the role planning policy can play in helping to build sustainable rural communities. It also examined how funds could be found to tackle rural decline and how local people could be more involved in the development of their villages.'
