10a) Request from 4Children to camp in Duchy Manor grounds – 'As you know, 4Children now manage 16 Children's Centres across Wiltshire, including the centre at Mere. We are developing a project to help families who would not otherwise go on holiday or camping. The aim is that during their stay staff would be modelling parenting skills and healthy lifestyles. We would run sessions on healthy and cheap meals, bedtime routines, positive behaviour management and basic computer skills as well as fun activities with children. As Mere Children's centre is our largest and has very good facilities such as a large kitchen, a shower as well as a computer suite, we wanted to pilot the project there. Also the centre is near numerous activities for the children. We wondered whether it would be possible for us to camp on the land outside the Centre. It would be for one week (the first week in August 2012) and would be no more than 4 families at a time for 2 days each – so a total of 8 families. There would be staff supervision at all times. I would be grateful if you could contact me and let me know whether this would be possible.' 11b) Policy R2: Provision of New Outdoor Sport & Recreation facilities – Wiltshire Council writes: 'The Council will be aware that for a number of years the local planning authority has been requiring applications for residential developments to make financial contributions towards the cost of providing outdoor sports and recreation facilities where there is a demonstrable deficiency in local provision. These are generally referred to as "R2 contributions". Recently some applicants have started to challenge the requirement for R2 contributions on the grounds that the evidence to justify them is insufficient to demonstrate a need within particular communities or villages. A number of these challenges have provide to be successful at appeal, with no resulting contribution. In view of this the local planning authority is now seeking assistance from local councils to help provide both relevant and up to date evidence of need. Without up to date evidence it will become increasingly difficult to ask for R2 contributions within your area. The information that is required includes the following:

- Details of the actual amount and location of recreation land and play areas within the Council's area;
- Details of the equipment/facilities provided within each recreational area (e.g. football pitches) and play areas (e.g. no. of swings, slides, etc) within the Council's area;
- Details of any known deficiencies in actual equipment (both children's play equipment and youth/adult facilities) at existing and/or proposed public open spaces within the Council's area;
- Details of equipment which it is known will need replacement within the next five years.
